VARIATION AND CANCELLATION POLICY



- Once Climbs have been reserved, any change to the Climb date, time or number of Participants must be requested in writing.
- Table 1 and Table 2 below set out the timing of payments, including deposits required, and any fees payable relating to any variation or cancellation of Climbs

All fees will be invoiced at the time they are incurred.

For Buyers with credit terms, invoicing for Climbs will occur on the day prior to the Climb date.

All fees will be charged at the time they are incurred.

For Buyers who have completed a Credit Card Authorisation Form, processing of payment will occur at the time of booking or 14 days prior to the Climb date whichever is the later.

Please note that for payments made by credit card a surcharge will be applied.

All fees will be invoiced at the time they are incurred.

For Buyers with credit terms, invoicing of non-refundable deposits will occur at the time of the reservation or 3 months prior to the Climb date whichever is the later and the balance 14 days prior to the Climb date.

All fees will be charged at the time they are incurred. For Buyers who have completed a Credit Card Authorisation Form, processing of payment will occur in accordance with the Table 2 above. Please note that for payments made by credit card a surcharge will be applied.
